

# **WE CAN Temporary Privacy Policy**

## **Information about our organization and websites**

WE CAN Corporation is providing this notice to you of our Privacy Policy and practices and of the choices you can make about the way your information is collected via our website and how that information is used. Please read this Privacy Policy carefully and revisit this page from time to time to review any changes that may have been made.

WE CAN may amend this Privacy Policy at any time by posting the amended terms on this site. All amended terms automatically take effect on the date set out in the posted Privacy Policy, unless otherwise specified.

## **Sites covered by this Privacy Policy**

This Privacy Policy applies to the WE CAN website [www.wecancenter.org](http://www.wecancenter.org). The WE CAN website may provide links to third-party websites for your convenience and information, such as processing a donation via credit card. If you access those links, you will leave the WE CAN website. We do not control those sites or their privacy practices, which may differ from our own privacy practices. This Privacy Policy does not cover any personal data that you choose to give to unrelated third parties. We do not monitor or control the information collected by such sites or the privacy practices of any third parties, and we are not responsible for their practices or the content of their sites.

## **Types of information we collect and use**

In this policy, “personal information” or “personal data” means information about an identifiable individual that is subject to protection under the law in the jurisdiction in which you reside.

The WE CAN website collects information through a variety of different ways and for different purposes. If you choose to request from or provide information to WE CAN through the WE CAN website, you will have the option to provide the following information; name, telephone number, email address and to submit a message. We use this information to contact you about the services on our site in which you have expressed interest. We may also use your contact information to send you information about other WE CAN programs and services or subscribe you to our e-newsletter. WE CAN does not share any information collected via our website with third party entities. If you do not want to receive emails from WE CAN, you do not have to provide your email address. If you do not wish to receive text messages, you do not have to provide your phone number. However, by providing your email address and/or phone number, you are voluntarily providing consent to receive email announcements and phone calls related to WE CAN services.

In most cases, you provide us with your consent to use your personal data in accordance with this policy by providing us with that information. In some cases, we may specifically ask for your express consent if we believe that the information is sensitive, or our use of the information may include other uses not covered by this Privacy Policy or another privacy notice to which we have made available to you.

Like other websites, the WE CAN website automatically collects technical information about your visit (such as browser type, Internet service provider, platform type, internet protocol (IP) addresses, referring/exit pages, operating system, date/time stamp). We do not associate this information with other information about you. We aggregate this information for reporting about the WE CAN website to analyze trends, diagnose problems with our server and administer the WE CAN website, to track user movement and use, and to gather broad demographic information.

## **Communications from WE CAN**

If you provide your contact information, we will communicate with you by email or telephone and will make every effort to honor your preferences based on the information provided. You can opt-out of receiving future texts or emails at any time (see Opt-Out section below).

When necessary, WE CAN will send you service or program related announcements, which are not promotional in nature. If you do not wish to receive them, you may opt-out of receiving future emails or texts at any time.

## **Sharing of information**

WE CAN will not share mobile information with third parties/affiliates for marketing/promotional purposes. All other categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

In some cases, however, WE CAN may be required to share information as a result of applicable laws. For example, WE CAN may be required to disclose information as a result of a court order, subpoena or warrant. In addition, we may be subject to applicable laws, and asked to voluntarily provide information in order to assist in a law enforcement investigation or where the disclosure is necessary to protect our systems, our business or the rights of others. In these rare cases, we would be required to provide personal data without your permission.

## **Cookies and other digital markers**

WE CAN automatically gathers information through the use of cookies and other digital markers. Cookies and digital markers are small computer files that may be stored on your computer's hard drive or embedded in our website pages that enable us to identify you and track your visit on the WE CAN website. You may disable cookies on your computer by changing the settings in the preferences or options menu in your browser. If you choose to disable cookies, you may not be able to access certain areas of the WE CAN website. WE CAN's systems do not

have functionality to receive or recognize a Do-Not-Track signal sent by a customer through a browser.

## **Children's privacy**

WE CAN is committed to protecting the privacy needs of children and we encourage parents and guardians to take an active role in their children's online activities and interests. WE CAN does not knowingly collect information from children under the age of 13 and WE CAN does not target its websites to children under 13.

## **Your choices and opting-out**

We follow generally accepted industry standards to protect the personal data submitted to us, both during transmission and once we receive it.
